Leadership Conference/Training: Continue the Organization's value of leadership development and training by offering training for local class leadership and other leaders, both online and in-person, depending on location. Additionally, an annual training conference is held for key North American leaders, along with annual leadership events for a broader group of organizational and local class leaders to provide support, encouragement, and community for class leaders and shepherds.
